#### IMPORT OF INDUSTRIAL RAW MATERIAL

THE MINISTER OF FOREIGN TRADE  
(SHRI B. R. BHAGAT) : (a) The value of i-  
ndustrial raw materials imported into during  
the last year was Rs. 749-87 crores.

(b) Industrial raw materials canalised or  
otherwise imported by S.T.C. and M. M. T.  
C. in the same year were valued at Rs. 45-42  
crores and Rs. 18-35 crores, respectively.

THE PRIME MINISTER AND MINISTER  
OF PLANNING (SHRIMATI INDIRA  
GANDHI) : (a) and (b) There was a general  
consensus of opinion among the Chief  
Ministers during the National Development  
Council meeting held on April 19 and 20,  
1969 that the outlay for the State Sector in the  
Fourth Plan was inadequate and that it should  
be enlarged.

(c) and (d) Yes, Sir. Consultations are, at  
present, under way with the State  
Governments to finalise the Fourth Plan  
outlays of States in the light of the resources  
position that has emerged after the report of  
the Fifth Finance Commission.

THE DEPUTY MINISTER IN THE  
MINISTRY OF EXTERNAL AFFAIRS  
(SHRI SURENDRA PAL SINGH) : (a) Yes,  
Sir.

(b) The increase in the number of visitors  
to G. D. R. is largely connected with the 20th  
Anniversary Celebrations of the foundation  
of the G. D. R.

#### CEILING ON PRODUCTION OF COTTON CLOTHES

(b) whether Government have consulted the industry in this regard and if so, the details thereof ?

THE MINISTER OF FOREIGN TRADE (SHRI B. R. BHAGAT) : (a) The question of laying down targets of production of cotton textiles by the decentralised sector and the mill sector during the Fourth Plan period is under consideration of the Government.

**AMERICAN OFFICIALS' THREAT TO INDIA FOR TIES WITH HANOI AND VIETCONG**

\*a60. SHRI N. R. MUNISWAMY : Will the Minister of EXTERNAL AFFAIRS be pleased to state :

(a) whether it is a fact that the American officials in New Delhi warned India on the 20th September last that in case India strengthened its ties with Hanoi and Vietcong, it would imperil American aid to and trade with India ; and

(b) if so, what is the reaction of the Government of India in this regard ?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI DINESH SINGH) : (a) and (b) There was an exchange of views between the officials of the Ministry of External Affairs and the American Embassy on the 20th September, 1969. Such exchange of views is kept confidential. However it has been stated by the U. S. authorities that raising of the level of India's representation in Hanoi or the recognition of the Provisional Revolutionary Government in South Vietnam will have adverse reaction in U. S. A.

It is for the Government of India to decide their bilateral relations with foreign countries bearing in mind their national interests. U. S. Government does not dispute this position.

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH) :

(a) and (b) Yes, Sir. The matter is being pursued with the Ethiopian authorities in order to arrive at a solution of the problem to the satisfaction of all concerned.
