American officials' threat to India for ties with Hanoi and Vietcong

*260. SHRI N. R. MUNISWAMY: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether it is a fact that the American officials in New Delhi warned India on the 20th September last that in case India strengthened its ties with Hanoi and Vietcong, it would imperil American aid to and trade with India; and

THE MINISTER OF EXTERNAL AFFAIRS (SHRI DINESH SINGH):
(a) and (b) There was an exchange of views between the officials of the Ministry of External Affairs and the American Embassy on the 20th September, 1969. Such exchange of views is kept confidential. However it has been stated by the U. S. authorities that raising of the level of India's representation in Hanoi or the recognition of the Provisional Revolutionary Government in South Vietnam will have adverse reaction in U. S. A.

It is for the Government of India to decide their bilateral relations with foreign countries bearing in mind their national interests. U. S. Government does not dispute this position.
