of India in May 1967 and became exofficio Chairman of the Rajya Sabha and adorned the Chair for over two years Shri Giri has been one of the old guards of the Freedom Movement, having joined it as a young man of twenty two As an ordent disciple of Mahatma Gandhi, the Father of the Nation, he actively participated in the Satyagraha Movement and suffered privations. It is, however, the history of the trade union movement in this country that Shri Giri an abiding place of high earned esteem and affection Associating himself with the organisations of the working class movement from its earliest times, Shri Giri was President of the All India Trade Union Congress twice He was also one of the principal founders of the All India Railwaymen's Federation He was twice Minister for Labour in Madras, and was Minister of Labour in the Central Government during 1952-54. From 1957 to 1967 he occupied the position of Governor of three States Whatever office he held and in whatever capacity he functioned, his unswerving loyalty to the cause of the common man was his watch word He endeared himself to every one by his humility, courage of conviction and adherence to principles In the Rajya Sabha we shall remember him as a genial Chairman, as one who was responsive to the mood of the House and showed utmost consideration to all sections of the House.

I may add, Madam, that the Prime Minister would have been very happy to make this reference, but as she has to make a motion in the other House, she could not remain present But on her behalf and on my own behalf, I pay warm tributes to Shri Giri and wish him well

Well, I am one of you, a Member of this House, I sit in this House as a Member and often I am called upon

to preside. I had the privilege to be the deputy of the Chairman, Mr. V. V. Giri. I enjoyed his kir dness and courtesy and above all, I enjoyed his implicit confidence in me. As the Leader of the House has said, he was a man of vast experience. He understood men and matters very well and even though three were jarring notes sometimes from one section or the other, he always upheld the right of this House and of every Member. There were occasions when he allo chastised the treasury benches as he cha tised sometimes ue also. But he kept up the best traditions of democracy while he sat in the Chair and, therefore, we must place on record all this. He was here for a little more than two years or a little less than two years, but he left with us the best memories of a democrat who sat in this Chair and of his vast experience and of his knowledge of the human material not only here in this House but aroun! the country also. His confidence in de locracy was unbounded and, therefore, he stood up for the rights of the citizens of India through this Chair and through this august House. We wish him well in whatever he may do. He is no longer the Chairman; he keeps to himself the rights of an individual citizen and, therefore, we extend to him our good wishes. I hope tie House joins me in this tribute.

SHRI BHUPESH GUPTA (West Bengal): I think this is wrong . . .

SHRI BABUBHAI M. CHINAI: What I want to know is whether it is a fact and if so, on what grounds this order has been given and what further action does Government propose to take.

SHRI BHUPESH GUPTA: Madam, we are not concerned with all that.

THE DEPUTY CHAIRMAN: I have already said . . .

SHRI BHUPESH GUPTA: No, you said that they should place something here.

THE DEPUTY CHAIRMAN: I may have been misunderstood. I may have used a wrong word. Mr Bhupesh Gupta, let the Minister come and say something.

SHRI BABUBHAI M. CHINAI: How can you say that? We are all very much concerned about it. The Government has taken a policy decision to which we have agreed. Now, when the Supreme Court grants a stay order, naturally there should be some reason. We have to see on what grounds that stay order has been given.

SHRI B. K. P. SINHA: Madam Deputy Chairman, I do not understand why there should be a storm about this. I may inform my honourable friend that it is an interim order. It cannot be a judgment. There is a distinction between an interim order and a judgment. Interim stay orders are always one-line or two-line orders. No reasons are given. Only a stay is granted.

AN HON. MEMBER: Ex parte.

SHRI B. K. P. SINHA: Therefore, I do not see what purpose would be served by the Government coming here and repeating that one-line order that a stay has been granted. So far as the Government is concerned, I am sure that Government has appeared at this stage and the Government will and should take every step to upheld what it has done.
