#### INCREASE IN ENTRANCE FEE IN DELHI ZOO

### 691. SARDAR D.K.JADHAV: SARDAR GURCHARAN SINGH TOHRA :

Will the Minister of FOOD AND AGRICULTURE be pleased to state :

(a) whether it is a fact that the entrance fee in the Delhi Zoo ha<sup>5</sup> recently been increased from 20 paise to 50 paise per ticket;

(c) whether Government propose to give concessional tickets to children; and

(d) if not, the reasons therefor ?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE. COMMUNITY DEVELOPMENT AND COOPERATION (SHRI ANNASAHEB SHINDE): (a) Yes. The entrance fee has been increased from 25 paise to 50 paise *only for adult visitors*, with effect from the 1st June, 1969.

(b) Important Zoos in India such as Alipore Zoo, Calcutta and the Mysore Zoo are charging 50 paise per adult. The Alipore Zoo, besides this fee, charges an additional fee of 25 paise for the "White Tiger Enclosure". The Delhi Zoo also has the white tiger enclosure, yet no separate fees are charged for this but only an increase from 25 paise to 50 paise for adults has been effected in the Entrance Fee. (c) There has been no increase in the entrance fee for the children, who are allowed entry at 10 paise per child.

Government understand that the Study Group on Sociological Aspects of Labour Management Relations and the Committee constituted by the Commission to study the working and service conditions of sweepers and scavengers have in their reports submitted to the Commission referred to these aspects, Government is not, however, seized of the findings at present and will consider the matter on receipt of the recommendations of the Commission.
