(b) if so, what steps are being taken to revive the industry so that there can be no closure of mines and consequent retrenchment of employees ?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS AND MINES AND METALS (SHRI JAGANNATH RAO): (a) As per the returns received by the Indian Bureau of Mines, the number of mines reporting production of manganese, fell by 34 during 1968 and 20 during January to May, 1969 in Vidarbha. The corresponding fall in average daily labour employed was 2358 and 2538 respectively.

(b) Efforts are being made to step up exports of manganese ore, as also internal sales. Other Mining Organisations have also been addressed to examine the possibility of employing workers rendered surplus.

#### SETTING UP OF A SECOND OIL REFINERY IN ASSAM
