

t[THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA GHARAN SHUKLA) : (a) No instructions have been issued defining specifically the duties of peons. A statement showing the scale of Class IV staff for officers and sections is attached. (See below).

(b) The sanctioned strength of the posts of peons in the Commission of Scientific and Technical Terminology, which has been fixed on the basis of the recommendations of the Staff Inspection Unit of the Ministry of Finance is 20, out of which two posts are lying vacant. Action to fill the vacant posts is being taken. The existing peons have been distributed in such a way that they attend to more than one officer sitting either in the same room or in rooms which are quite close to one another. However, due to the shortage of staff, in the case of one peon he has to attend to four officers sitting in one room and one Section which is quite close to these officers, room. It is proposed to provide one separate peon to this Section when the two vacancies of peons are filled.

(b) whether it is also a fact that many such State Lottery tickets are sold in Delhi;

(c) whether it has come to the notice of Government that some fake lottery tickets have been printed by the selling agents to cheat innocent people; and

(d) if so, the remedial measures proposed to be taken by the Government of India to stop these irregular practices ?

(c) and (d) The Governments of Kerala Tamil Nadu, Maharashtra, U. P. and West Bengal have intimated that no case of fake lottery tickets has come to their notice.

t IMPROVEMENT OF FINE ARTS

(a) whether there is any proposal under Government's consideration to improve fine arts during the Fourth Five Year Plan period; and

(b) if so, the details thereof ?

THE MINISTER OF EDUCATION AND YOUTH SERVICES (PROF. V.K.R.V. RAO) : (a) and (b) There are a number of projects included in the Fourth Five Year Plan connected with the Sangeet Natak Akademi, Lalit Kala Akademi and the National Gallery of Modern Art which aim at encouraging and promoting the development of fine arts. Details of the projects are :

1. Lalit Kala Akademi—

An allocation of Rs. 25 lakhs has been made in the 4th Five Year Plan for the following projects amongst others !

- (i) Prints of Ancient and Contemporary Paintings.
- (ii) Circulating Exhibitions. (iii) Art Films,
- (iv) Copies of Frescoes and Murals.
- (v) Development of Studios for Artists, (vi) Central Institute of Art.

2. Sangeet Natak Akademi—

An allocation of Rs. 20 lakhs has been made in the 4th Five Year Plan for the following activities :

- (i) Establishment of a Research Laboratory for the study of science of music.
- (ii) Development of the Akademi Museums.

(iii) Survey of folk music, folk dance and folk drama of India.

(iv) A scheme for the award of Fellowships to artists in the lesser known forms of Indian Music and Dance.

3. National Gallery of Modern Art—

An allocation of Rs. 26 lakhs has been made in the 4th Five Year Plan for the following schemes :

- (i) Publication and coloured reproductions.
- (ii) Development of Restoration Laboratory.
- (iii) Acquisition of Art Objects.
- (iv) Exhibitions, Seminars, Symposia and Lectures.
- (v) Education Research facilities.
- (vi) Western and Eastern Art Sections.
- (vii) Development of Art Reference Library.
- (viii) Development of Photographic Studio.
- (ix) Additional Staff requirements.
