

- (2) Ministry of Food, Agriculture, Community Development and Cooperation.

- (6) Ministry of Defence.

(c) 34 complaints were pending with the Central Vigilance Commission on 31st December, 1968, but have since been disposed of by the Central Vigilance Commission by forwarding them to the Ministries concerned.

(d) Up to 31st July, 1969 action has been taken as follows :—

Recovery was ordered from the pay of 2 officers one of whom was also censured. Government's displeasure was conveyed to one officer while another was warned. 3 cases have been registered by C.B.I. for regular investigation while departmental action has been recommended against 3 officers.

(e) The question of affording relief to any person did not arise.

(b) and (c) During the period from 19-8-1968 to 15-7-1969, 20,176 criminal cases were reported to Delhi Police as against 20,992 cases during the corresponding previous period. The figures for murders are 86 and 63 respectively.
