While forwarding the invitation to the Ministry oi' External Affairs, the U.S. Embassy had indicated in their Note that the terms ot invitation included domestic transportation within United States and an appropriate per diem allowance to cover their board and lodging.

(c) and (d) While clearing the visit the Ministry of External Affairs in their Note to the U.S. Embassy pointed out that it was not customary for a Government to offer daily allowance to a foreign dignitary that it invites, though it is open to the inviting Government to offer local hospitality, if it so chooses. The U.S. Embassy have acknowledged the Note.

The Ministry of External Affairs brought the above facts to the notice of the Ghiet Minister of Orissa also.
