INDIAN NATIONALS IN BURMA

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH) (a) There are approximately 68,000 Indian nationals in Burma.

(b) 1,74,500 (approx.)

(c) The Government of India have been making every effort through diplomatic channels to alleviate the problems faced by Indian nationals and persons of Indian origin living in Burma. This

question was raised with the Burmese Government during the Prime Minister's recent visit to that country. The Burmese Government assured us that they would endeavour their utmost to settle these outstanding matters sympathetically and expeditiously.
