In so far as the interest-free loan given by the Central Government is concerned, steps have been taken to safeguard the amount of loan.]

- THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING AND IN THE DEPARTMENT OF COMMUNICATIONS (PROF. SHER SINGH): (a) No. Madam.
- (b) The last telephone directory December, 1966 issue printed on Circle basis was published in March, 1967. Since then approximately 6,000 telephone connections were given. Due to certain difficulties there was going to be delay in printing of the next Circle Directory the Postmaster General brought out a directory for Shillong Exchange in February, 1968 and further issued cyclostyled lists of exchanges wherever new exchanges were opened.
- (c) The latest issue of the telephone directory of the Circle is now under print. The telephone directory is normally published once a year but the December, 1967 issue could not be brought out as advertising agent could not be appointed for a long time due to death of the proprietor of previous advertising firm. A new advertising agent has now been appointed. The next issue of the directory is expected to be available for issue any time now.
