## INCREASING COST OF WHITE PRINTING PAPER

- 1071. SHRI SITARAM JAIPURIA Will the Minister of INDUSTRIAL DE-VELOPMENT, INTERNAL TRADE AND COMPANY AFFAIRS be pleased to state:
- (a) whether it is a fact that the cost of white printing paper is increasing day by day
  - (b) if so, the reasons therefor;
- (c) what is the annual production and demand of the printing paper which is used for the printing of text books;
- (d) the names of the paper mills with their annual capacity; and
- (e) what steps are being taken to increase the production of the paper under the Fourth Five Year Plan?
- THE MINISTER OF INDUSTRIAL DEVELOPMENT, INTERNAL TRADE AND COMPANY AFFAIRS (SHRI FAKHRUDDIN ALI AHMED): (a) From June, 1962 to April, 1968 there was no increase in the prices of paper. After the removal of control of the price of paper from 3-5-1968, there has been increases in price.
- (b) Increase in the cost of production of paper has been cited as the reason for increase in the prices of paper.

- (c) No separate figures for printing paper used for the printing of text books are available.
- (d) A list is attached. [See Appendix LXIX, Annexure No. 83].
- (e)(i) Paper Industry has been exempt" ed from the licensing provisions of the Industries (Development & Regulation) Act, '51.
- (ii) Certain concessions are given in excise duty to encourage the setting up of additional capacity.
- (iii) Paper Industry is listed as a Priority Industry which makes it eligible for concessions in the matter of import of raw materials and components.
- (iv) In order to augment the production of paper it is proposed to establish some paper/pulp Mills in the Public Sector also.

## FILLING OF POSTS OF STENOGRAPHERS ON ad hoc basis
