

THE MINISTER OF STATE OF THE MINISTRY OF TOURISM (SHRIMATI RENUKA CHOWDHURY): (a) and (b) A 20 year Perspective Plan for sustainable development of tourism in the state has been prepared during 2002-2003.

(c) Development and promotion of tourism is primarily the responsibility of the State Governments/UTs. Ministry of Tourism provides financial assistance for the tourism projects identified in consultation with the state concerned after ensuring their viability. Ministry of Tourism has been supporting State Government of Assam for development of tourism infrastructure, development of Tourism Circuits and Rural Tourism projects. During first two years of Tenth five plan, total amount of Rs. 1081.59 lakh was sanctioned for tourism projects including rural tourism project to the State of Assam.

During the current year 2004-05, Rs. 487.75 lakh has been sanctioned for Development of NE Circuit in Guwahati and Rural Tourism at Sualkuchi in the Kamrup District.

Identification of tourist spots in Maharashtra and Punjab
