SHRI NIREN GHOSH: The firms belonging to the persons from whom income-tax arrears of over Rs. 50 lakhs are due should be blacklisted. Has the Government considered this proposal, also the proposal that credit facilities should not be extended to the business houses from whom income-tax arrears of over Rs. 50 lakhs are due as a penal measure, because all other measures have failed, and it is a great scandal with them?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS AND MINES AND METALS (SHRI D. R. CHAVAN) : (a) and (b) An application under the Industries (Development and Regulation) Act, 1951 for the establishment of a fertiliser plant at Bhatinda in the Punjab was received in September, 1967 from the Punjab State Industrial Development Corporation. Subsequently the Corporation did not show much interest in pursuing the matter and was informed in June, 1969 that it was proposed to reject the application subject to any representation that the Corporation might like to make in this regard. The proposal is being further examined in the light of representations since received from the Corporation.
