out of a total of 770 salary earners/ employees' co-operative societies at the beginning of 1966, 424 societies have been exempted by the Reserve Bank from the purview of the Banking Regulation Act (as applicable to cooperative societies).

Written Answers

- (c) and (d) The Government of West Bengal recommended in June, 1966, that the provisions of the Act specially those relating to the maintenance of minimum cash reserves and liquid assets in respect of urban cooperative credit banks should be relaxed.
- (e) Since such relaxation would have defeated the purpose of extending the regulatory provisions of the Banking Regulation Act to cooperative banks, the recommendation was not accepted.

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI P. C. SETHI): (a) The Ail India Rural Credit Review Committee appointed by the Governor of the Reserve Bank submitted its report on 30th July, 1969.

- important recommendations relate to (i) the establishment of an Agricultural Credit Board in the Reserve Bank of India, (ii) the setting up of a Small Farmers Development Agency in each of a number of selected districts throughout the country, (iii) the creation of a Rural Electrification Corporation to benefit undeveloped areas with agricultural potential, (iv) formulation of a more active and much bigger role for the Agricultural Refinance Corporation along with the enlargement of its resources and (v) the adoption of a number of measures for ensuring the timely and adequate flow of credit for agriculture through cooperative and commercial banks.
- (c) Based on the interim recommendations made by the Review Committee in February, 1969, the proposals concerning the Small Farmers Development Agency, the Rural Electrification Corporation and the Agricultural Refinance Corporation are in the process of implementation. The other recommendations of the Review Committee are presently under consideration of the Reserve Bank.
