(a) whether il is a fact that the 6-Dn. Allahabad-Gorakhpur Express was derailed on the 21st June, 1969 between Jakhania and Dulapur stations in the Allahabad-Gorakhpur section of the North Eastern Railway resulting in the death of a number of persons;

(b) if so, the number of persons killed as a result of the accident:

(c) whether the cause of the accident has been investigated;

(d) if so, the results thereof;

(e) the action taken or proposed to te taken by Government in the matter ;

(f) whether any report has since been received from the Central Intelligence Department ruling out sabotage as the cause of the accident;

(g) if so, the reasons that prompted him to make a statement soon after the accident that it was due to sabotage;

(h) the names of the persons who have been arrested or held responsible for the accident;

(i) whether Governmeni propose to compensate the families of the peisor.s killed in the accident; if so. the amounts thereof ; and

(j) the number of casualties from whose person some amount of money was collected by the police and whether these amounts of money have been handed over to the members of their families? (b) In this accident 72 persons were killed.

(c) and (d) The Additional Commissioner of Railway Safety, Calcutta has held his statutory inquiry into this accident. According to his provisional finding, the accident was due to sabotage of track committed by unknown persons.

(e) Action as necessary will be taken on receipt of the Inquiry Report.

(f) No.

(g) In view of the answer to parts (c), (d) & (f) above, does not arise.

(h) There is no information of any arrest having so far been made in connection with this accident.

(i) The amounts of compensation to be paid will be decided by the Claims Commissioner.

RAM SUBHAG SINGH) : (a) and (b) One Third Class Coach scheduled to run between Khejuriaghat and New Bongaigaon by 5 Up Express was wrongly detached at Kumedpur along-with 4 sectional coaches for Katihar which were correctly detached at Kumedpur) and despatched incorrectly to Katihar by 61 Up Passenger on 15-6-69.

(c) Yes.

(d) Disciplinary action lias been taken against the staff responsible in this case. Lapses on the part of the staff are duly taken up for appropriate action.

SHORTAGE OF PIG IRON

66. SHRI MULKA GOVINDA REDDY : Will the Minister of STEEL AND HEAVY ENGINEERING be pleased to state :

(a) whether it is a fact that there is a shortage of pig iron in the country;

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND HEAVY ENGINEERING (SHRJ *K.C.* PANT):

(a) The present assessment is that production of pig iron is generally adequate to meet the estimated requirements, although there have been some^pccasional shortages in supplies Ol certain glides.

(b) Hindustan Steel .Limited has beep advised to increase production of pig iron of grades in short suppiy. The Joint Plant Committee has also evolved an equitable sustem of distribution of pig iron so that all users get adequate quantifies. Exports of basic grade pig iron have also been restricted.
