and (b) The railways undertake works for construction of road over/under bridges in *replacement of existing busy level crossings*, provided the individual schemes are sponsored by the State Government/ Road authority indicating the relevant priority and the year in which the State Government/Road authority will be able to take up their portion of the work and on their undertaking to bear 50% cost of construction of the bridge and the approaches and total cost of land acquisition, if any.

(c) and (d) So far, there is a tentative proposal from the Government of Bihar for construction of a road over-bridge during the fourth plan period in replacement of the existing level crossing at Kodarma station only. The railway will take necessary follow up actio" as soon as the State Government communicate their final approval to the proposal indicating the priority and allocation of funds.]

THE MINISTER OF INDUSTRIAL DEVELOPMENT, INTERNAL TRADE AND COMPANY AFFAIRS (SHRI EAKHRUDDIN ALI AHMED) : (a) The Central Industrial projects included in the Fourth Plan are indicated on pages 253—257 of the Draft Fourth Five Year Plan Report. Although no specific Central project in Punjab has been included in the Draft Fourth Plan, consideration is being given to ,he expansion of the Nangal Fertiliser Project on which detailed studies are currently in progress.

(b) Yes. Madam.

(c) The State Government has desired that some of those projects which are included in the Draft Outline of the Fourth Plan and for which locations have not yet been decided, should be located in Punjab. The request of the State -Government for locating the central industrial projects in that State will be kept in view at the time of finalising their location, after a final decision on their implementation is taken.
