(c) Yes, Madam.

(d) A three man technical team including an officer each from the Directorate General of Technical Development, Chief Controller of Printing & Stationery and Hindustan Machine Tools has visited Shri Handa's factory and submitted a report on the rotary machine produced before the team. The report is under examination.
