The amount of profits remitted by foreign tea companies during 1967-68 is Rs. 5\*04 crores and that by foreign rubber companies during the same period is Rs. o-86 crores. This latter figure, however, includes the remittances in respect of the tea estates owned by the foreign rubber companies.

Government have not felt it necessary to consider the question of nationalising the Plantations.

The programmes for the development of plantations proposed during the Fourth Plan period are under consideration.
