Participation of private sector in boosting tourism industry

- 2032. SHRIMATI HEMA MALINI: Will the Minister of TOURISM be pleased to state:
- (a) whether government have any concrete time-bound action plan to made India among the preferred destination of international tourists;
 - (b) if so, the details thereof;
- (c) what is the extent of private sector participation in boosting the country's tourism prospect of investment made in the preceding financial year; and
- (d) what are the road blocks on way to India as the international tourism hub and measures to remove the same?

THE MINISTER OF STATE OF THE MINISTRY OF TOURISM (SHRIMATI RENUKA CHOWDHURY): (a) and (b) Marketing and promotion

of India as a preferred tourist destination is an ongoing activity of the Ministry of Tourism. Adouble pronged strategy adopted by the Ministry of Tourism for upgrading tourism infrastructure in the country along with strategic marketing initiatives, is aimed at positioning India as a preferred tourism destination in the world.

- (c) Tourism comprises a range of sectors like hotels, tourist transport, travel agencies, tour operators, guides, etc., which are primarily run by the private sector. Most of the investment in tourism is, therefore, in the private sector.
- (d) The Government has initiated various steps to accelerate growth of tourism in the country. These include augmenting of international air seat capacity and provision of incentives for expanding hotel accommodation.
