Taouse rent allowance, have as a consequence increased. Only in the case of employees in Glass 'A' and 'B-i' cities who are in occupation of Government accommodation for which rent is actually paid at 10 per cent of pay, increased deduction from pay has occurred. This, however, cannot be helped since Dearness Pay is reckoned uniformly as pay for both house rent allowance and house rent recovery.

- THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS AND MINES AND METALS (SHRI JAGANNATH RAO): (a) Against the estimated requirement of 77,200 tonnes of copper during 1968-69, the imports of copper and alloys, was 43,023 tonnes.
- (b) Prospecting of copper is being carried out by the Geological Survey of India. Sizeable copper ore bodies have been located in Singhbhum District of Bihar, Jhunjhunu and Sikar Districts of Rajasthan and Guntur District of Andhra Pradesh.

A search for Base-metal deposits including copper by Aerial Geophysical Surveys followed by ground work has also been taken up. The aerial survey has covered an area of 91,400 square Kilo-meters in Arr-avali Region in Rajasthan, Eastern Cudda-pah Basin in Andhra Pradesh and parts of Bihar-Bengal. The ground follow up action is in progress in all the three areas.

Investigation in other promising areas are also under way.
