THE DEPUTY MINISTER IN THE INISTRY OF IRRIGATION AND MINISTRY OF (PROF. POWER **SIDDHESHWAR** PRASAD): (a) and (b) Under the Indus Waters Treaty, i960, India is required to make certain deliveries of water from the rivers Ravi, Beas and Sutlej to Pakistan during the "Transition Period". The present indications are that this Period will end on 31st March, 1970. After the end of the Transition Period, India would not be required to supply any water to Pakistan from the rivers Ravi, Beas or Sutlej. All the waters of the river Sutlej are already being utilized by India. As to the waters of the rivers Ravi and Beas, some storages on Beas have already been undertaken, in order to conserve the waters and some project reports are under preparation. As soon as the storages are completed and the Rajasthan Canal is fully developed, all the waters would be completely utilised in India.
