

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR, EMPLOYMENT AND REHABILITATION (SHRI BHAGWAT JHA AZAD): (a) Yes, Madam.

(b) No such proposal is presently under consideration.

(c) The main functions of Stevedore employers are to prepare stowage plans of ships with a view to ensuring that the maximum quantity of cargo is stowed in the place available without endangering the sea-worthiness of the ships, to carefully study hatch plans before unloading starts, to allot workers to different hatches according to actual requirements to give suitable directions as to how much cargo in each hatch has to be handled, to maintain and provide adequate handling gear, to arrange for the shifting of cranes and to provide protective equipment for the safety of dock workers. They are also responsible for providing expert supervision over the loading and unloading operations.

#### ABSORPTION OF STAFF OF FOOD DEPARTMENT IN FCI

(b) if so, whether any assurance was given by Government that no discrimination will be made between the Regional and the Secretariat staff in the matter of absorption in the Corporation; and
