(c) and (d) As stated in reply to parts (a) and (b) of the question, credit for fisheries development has been accepted and is already provisionally covered by an agreement. An agreement has not yet been arrived at regarding the terms and conditions under which the rouble credit earmarked for fisheries can be utilised.
