

**SUGGESTIONS MADE BY TRAVEL AGENTS
ASSOCIATION OF INDIA**

DR. BHAI MAHAVIR :

Will the Minister of **TOURISM AND CIVIL AVIATION** be pleased to state :

(a) whether it is a fact that the Travel Agents Association of India has discussed problems of tourism in a recent conference held at Kathmandu, Nepal and made certain suggestions to the Government to create better conditions in the country to encourage inflow of foreign tourists ;

(b) if so, what are the suggestions made by the Travel Agents Association of India in this regard and the reaction of Government thereof ; and

(c) what steps Government propose to take to promote tourism with the the neighbouring countries ?

THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH) : (a) Yes, Madam.

(b) The Travel Agents Association of India recommended (i) improvement to terminal facilities at international airports; (ii) immediate selection and purchase of aircrafts for the Indian Airlines ; (iii) introduction of excursion and group fares on Indian Railways and Indian Airlines ; (iv) introduction of all-India permits for tourists vehicles and grant of import licences for tourist cars and coaches to the Travel Agents. The Association also recommended that for regional promotion of tourism in the South Asia Travel Commission region, viz., Afghanistan, Iran, Pakistan, Ceylon, Nepal, Outer Mongolia and India, there should be a joint promotional machinery, joint publicity, joint tourist visa, joint health, customs and immigration clearance facilities for countries of this region and further that all restrictions on travel for countries within the region be removed and travel to countries with which there is barter trade be free.

The recommendations are being examined by Government.

(c) A ministerial Conference of the South-Asia Travel Commission member-countries was held in Delhi on the

14th and 15th March 1969 on the initiative taken by India to consider how best to achieve the promotion of tourism to the region as a whole, utilizing to the maximum extent the available facilities of the member countries. The Conference adopted resolutions aimed at joint promotion of tourism to countries in the region as also larger flow of tourists from one country to other countries within the region.
