dredging work at Paradeep Port 1s in progress. After dredging a part of the sand trap and the channel before the on-set of monsoon, the firm's dredger is now working on the widening of the Turning Circle. The sand trap was expected to be completed before the on-set of monsoon; however, this could not be done. As soon as the widening of the Turning Circle 1s completed and the monsoons are over, the work on sand trap will be resumed. According to present indications, the entire work is expected to be completed by the end of this year.

These incentives are available to hotel projects approved by the Government all over the country, including the State of Tamil Nadu.
