THE MINISTER OF STATE (DEFENCE PRODUCTION) IN THE MINISTRY OF DEFENCE (SHR.1 L. N. M1SHRA): (a) Though no fresh major industrial dispute was raised in 1969, three demands that had been pending for sometime were pressed by employees' Unions.

#### These were:

- (i) Demand made by all Labour Unions of HAL for payment of Dear-ness Allowance at Central Government rates;
- (ii) Demand made by all Labour Unions of HAL for revision of HAL Wage Structure and payment of Interim Relief at 25% of total emoluments till wage revision is completed; and
- (ii) Demand made by the Union at Koraput protesting against proposal for phase deduction of project al-lowanse and asking for either continuance of project allowance at existing rates or its replacement by a Koraput Allownace at higher rates.
- (b) and (c) The Dearness allowance dispute has been settled by the HAL Management agreeing to pay to their employees dearness allowance at Central Government rates pending determination of the Wage Structure and allowances in the light of discussions with reference to the Engineering Wage Board's Report. HAL Mangement have also commenced negotiations with the Employee's Unions in regard to the revision of the Wage Structure. Pending consideration of the demand for payment of special Koraput Allowance to the employees of Koraput Division, continuance of the Project Allowance at existing rates has been sanctioned till December, 1969.

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS fSHRI SURENDRA PAL SINGH) i (a) to (c) India's well known views regarding arms supplies to Pakistan are constantly brought t\* the notice of foreign Governments through diplomatic channels. The concerned Governments have been

informed that any further arms build up by Pakistan poses a threat to the security of India, creates tension in the sub-continent and retards the chances of normalisation of relations between the two countries.

### SOVIET ARMS TO PAKISTAN

316. SHRI JAGAT NARAIN SHRI N. R. MUNISWAMY i

Will the Minister of DEFENCE be pleased to state:

- (a) whether Government are aware that Pakistan recently received from Ruassia a contingent of 60 tanks bringing the number of Russian tanks to 100; and
- (b) if so, what is the reaction of the Government of India in regard thereto?
- THE MINISTER OF DEFENCE (SAR-DAR SWARAN SINGH): (a) According to our information, the Soviet Union have supplied about 50 T-55 tanks to Pakistan in May. This is in addition to about 50 tanks supplied by them in Feb-bruary.
- fb) Pakistan has no reasonable justification for augmenting its armed strength. Such supplies of military equipment to Pakistan would only accentuate tension in the subcontinent and add to our responsibilities in regard to the defence and security of the country.
