THE MINISTER OF EXTERNAL AFFAIRS (SHRI DINESH SINGH) : (a) and (b) In its Advisory Opinion to the Government of Costa Rica the Supreme Court of Costa Rica has advised against India's request for the extradition of Dr. and Mrs. Teja by a majority decision of 10 against 7. The Government of Costa Rica are yet to consider the Advisory Opinion and to reach a final decision on the Government of India's request. The Government of India propose to prefer a formal representation to the Government of Costa Rica reiterating their stand in the case.
