THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH):
(a) The Governments of Afghanistan and India have been desirous that the traditional trade route between the two countries should remain open.

(b) It is upto the Government of Pakistan to open the route. There is, therefore, no question of any request being addressed to the Government of India.

(c) In view of (b) above, the question does not arise.

PENSIONS TO WIDOWS OF SOLDIERS KILLED IN WAR

- (a) whether the opinion of the Comptroller and Auditor General of India has been received for giving pension and other facilities to the widows of the soldiers killed in war;
- (b) if so, what is Government's reaction thereto; and
- (c) what action Government have taken in this regard?

OF DEFENCE THE MINISTER (SARDAR SWARAN SINGH) 1 (a) to (c) Government orders regarding grant of special family pensions to widows of Service personnel killed in action were issued in 1965. The Comptroller and Auditor General was requested to look into the deductions made by the Controller of Defence Accounts (Pensions) in relation to the scholarships awarded by Government to children of certain widows for education in public schools. The Comptroller and Auditor General indicated that, on the face of it, the Controller of Defence Accounts (Pensions) had acted correctly. Government, however, meanwhile issued a clarification to the effect of which was to restore in full the consolidated rates of special family pension to war widows.
