rage waiting period for the entire country will rise from the present  $4 \cdot 3$  years to 5 years by the end of the Plan period. For Kerala it will rise to about 4 years from the present  $3 \cdot 3$  years. As on 31 - 3 - 69 Kerala Circle had an equipped capacity of 42, 135 lines with 32, 194 direct exchange lines and a waiting list of 15262. It is proposed to increase the capacity by about 26,000 lines during the IV Plan.

## PUBLICATION ON THE LIFE AND TEACHINGS OF GURU NANAK

393. SARDAR GURCHARAN SINGH TOHRA : Will the Minister of IN-FORMATION AND BROADCASTING AND COMMUNICATIONS be pleased to state :

(a) whether Government propose to bring out a scries of publications on the life and teachings of Guru Nanak on the occasion of his 500th birth anniversary in November this year;

(b) if so, what are the details thereof; and

(c) whether the A.I.R. Stations have been instructed to broadcast the teachings and messages of Guru Nanak during that period?

THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING AND IN THE DE-PARTMENT OF COMMUNICATIONS (SHRI I. K. GUJRAL) : (a) and (b) It is proposed to bring out a publication in English, Hindi and Punjabi on the life and teachings of Guru Nanak. The book would include articles on the various aspects of his personality and teachings by eminent writers and some of his sayings. It is also proposed to bring out a short biography of Guru Nanak in Hindi meant for children and readers of average education.

(c) Yes, Madam. Heads of stations of all India Radio have been asked to arrange special programmes during the months from October to December, 1969. The special programmes to be broadcast by stations will be features, series of talks, recitations from the holy Granth Saheb, Shabad Kirtan, hymns etc. Regional stations will broadcast programmes in their respective regional languages.
