produce varies from year to year. The details for 1967-68 are howeveer as follow:

- (b) The forest produce is disposed of mainly in the following ways:—
 - (i) Timber logs by-
 - (a) sale to local Plywood Factories and to the Match factor es on the Island and the munland;
 - (b) on the mainland by sale to the Railways through Directorate General of Supplies and Disposals and other Government and Semi-Government Institutions through the Departmental Depots at Calcuita and Madras;
 - (c) conver ion in departmental Saw Mills at Chatham and Betapur for local sale to the local public and Government Deptts. as well as for disposal in the Departmental Depots in the mainland at Calcutta and Madras;
 - (d) sale to private Saw Millers for conversion in their Saw Mills
 - (ii) Ballies at d Bamboos are used both by Jovernment Departments as well as Public in making emporary hutments fencing etc
 - (iii) Firewood is used mainly for running of Steam-Vessels and Power House;
 - (iv) Canes are used by Forest Departments for rafting of logs and part of it is utilised by Jail and Cottage Industries Department for furniture making.
 - (vi) Dhoop Resin extracted by lesses is disposed of by them directly.
- (c) Yes, Madam. The saw-mill installed at Chatham by Covernment is running

at a loss. Based on the figures given in the proforma accounts of the forest Department for the last three years the average annual loss works out to Rs. 35,96,228. Reasons for losses mainly are—(i) High Cost of logs as fixed by the commercial system of accounting adopted by the Department; (ii) sawing of inferior quality logs yields poor out-turn of sawntimber; (iii) Use of old and out-moded machinery and equipment; (iv) increase in the cost of stores used in the saw mill: (v) increase in pay and allowances given to the industrial employees due to liberalised service conditions; and (vi) sale of sawn timber in the Islands and on the mainland markets at rates lower than the cost of production.

Steps taken to obviate the losses are (1) re-examination of costing of raw-materials in proforma accounts (2) replacement of old and out-moded machinery and equipment on phased basis; and (3) consideration for increase in the rates for local sale of sawn timber.

FAMINE AFFECTED AREAS

367. SARDAR HARCHARAN SINGH DUGAL: Will the Minister of FOOD AND AGRICULTURE be pleased to state:

- (a) the names of regions in the country which are at present declared as famine affected areas in different States and how long famine conditions have continued to exist there so far ;
- (b) whether any Study Team of the Planning Commission has recently visited those areas and if so, what is their assessment of the prevailing conditions there ;
- (c) whether the Study Team has made any recommendations to remove famine conditions from those areas and to provide help to the famine striken people and if so, the details thereof; and
- (d) the decision taken by Government on the recommendations?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRI-CULTURE, COMMUNITY DEVE-LOPMENT AND **CO-OPERATION** (SHRI ANNASAHEB SHINDE) : (a) No State Government have reported declaration of any area as famine affected area. However, owing to the failure of rains in 1968-69, drought conditions have appeared in parts of some States. A list of the States affected is attached. (Statement I). (See below).

(b) to (d) Central Teams are sent to States affected by drought to assess the requirements of funds fot immediate relief operations. A Statement indicating the ceilings of expenditure, recommended by the Teams, during 1968-69 and 1969-70 and the assistance released so for is att-(Statement II). No request for sending a Central team to Bihar had been received from the State Government.
