

†[THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY PLANNING AND WORKS, HOUSING AND URBAN DEVELOPMENT (SHRI B. S. MURTHY) : (a) The Ayurvedic System of Medicine is the oldest system of Medicine in India and one of the oldest in the world. Its achievements are recorded in the classics on the subject.

(b) No. Encouragement is being given to the Ayurveda along with the Modern System of Medicine.

(c) Provision has been made in the successive four Five Years Plans for the development of scientific researches in the different aspects of Ayurveda, fundamental and applied, as well as post-graduate education in the Central Sector, and for upgrading and establishment of undergraduates colleges, hospitals, dispensaries and pharmacies in the State Sector. The following allocations have been made during the four Five Year Plans :

(d) Opportunities for special study exist at the Post-Graduate Institute in Indian Medicines and Research at Banaras Hindu University, and the Gujarat Ayurvedic University. With the all round encouragement being given to Ayurveda, it is expected that there will be adequate avenues for the employment of qualified Vaid. Some of the States have set up standard Pharmacies. The question regarding reimbursement of medical expenses to Government employees for treatment under the Ayurvedic system is under consideration.]
