THE MINISTER OF STATE IN THE MINISTRY OF LABOUR, EMPLOYMENT AND REHABILITATION (SHRI BHAGWAT JHA AZAD): (a) and (b) The Report of National Commission on Labour was submitted to Government on the 28th August, 1969. A copy of the Report is being placed on

the Table of the Sabha. The recommendations made by the Commission in respect of minimum wages, will be considered by the Government in consultation with the interests concerned.

- THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING AND IN THE DEPARTMENT OF COMMUNICATIONS (SHRI I. K. GUJRAL): (a) Yes, Madam.
- (b) The matter was examined by the Ministry of Information and Broadcasting. It was not required to be referred to Ministry of Home Affairs.
- (c) The strike was called by Central Government employees in general and not individually by each office. For absenting himself from duty on the day of the strike, the Assistant Producer concerned did not obtain prior permission from the Station Director which was necessary under the contract.
- (d) The genuineness of the absence has been enquired into departmentally. Consultation with Home Ministry was not necessary.
