THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING AND IN THE DEPARTMENT OF COMMUNICATIONS (SHRI I. K. GUJRAL): (a) Yes, Madam.

(b) In their report submitted to Government on 31-7-1969, the Enquiry Committee on Film Censorship have *inter-alia* recommended that if in telling the story, it is logical, relevant or necessary to depict a passionate kiss or a nude human figure, there should be no question of excluding the shot, provided the theme is handled with delicacy and feeling, aiming at aesthetic expression and avoiding all suggestion of unnecessary prurience or lasciviousness.

(c) It will take some time for Government to examine the entire report and take decisions.

(b) This Ministry is not aware of any such visit.
