(c) the amount of grants/loans advanced to this news agency by the State Governments/Central Government during the years 1966-67, 1967-68 and 1968-69 and the amount received from the business conducted during the years ; and

(d) the expenditure incurred by the News Agency in various Branch Offices/ Headquarters Office at New Delhi during the period mentioned above ?

No grants have been given to the Samachar Bharati either by the Central or the State Governments.

The loan has been advanced with a view to improving the existing arrangements for the collection and distribution of news and feature services in Indian languages, particularly, in Hindi for which the news agency was set up. Repayment of loan will commence from 1972.

BIRLA'S MOIRA COLLIERY

SHE I PRANAB KUMAR MO-KHERJEE :

Will the Minister of LABOUR AND REHABILITATION be pleased to state :

(a) whether Government have received serious complaints against Birla's Moira Colliery, West Bengal ;

(b) if so, what are the details thereof ; and
(c) what steps Government have taken in the matter ?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR, EMPLOYMENT AND REHABILITATION (SHRI BHAGWAT JHA AZAD) : (a) and (b) We have received some complaints. These relate mainly to alleged assault and wrongful confinement of a worker in the Colliery Manager's bungalow, death of a worker's newly-born baby and lockout of the Colliery by the management.

(c) It has been reported that there was no lockout of the Colliery and the Colliery is working normally. The other allegations, which relate to alleged criminal offences, are under investigation by the State police authorities.

RICE SUPPLY TO KERALA

^{799.} SHRI KESAVAN (THAZHAVA) : Will the Minister of FOOD AND AGRICULTURE be pleased to state :

(a) the quantity of rice supplied to Kerala by the Central Government or the Food Corporation of India during 1968-69 and so far in 1969-70 ;

(b) what was the issue price of rice supplied to Kerala during the above period ; and

(c) what was the procurement price of rice from Andhra Pradesh and the North Indian State during the above period ;

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE COMMUNITY DEVELOPMENT AND COOPERATION (SHRI ANNASAHEB SHINDE) : (a) All rice supplied to Kerala by Central Government is issued directly from the Food Corporation of India's depots in Kerala to the fair price shops and other nominees of the State Government. The quantities issued were:

(b) The price at which coarse rice was or is being supplied by the Food Corporation to the nominees of the State Government during the said period are :—

TELEPHONE CONNECTION IN BARODA CITY

(a) whether it is a fact that a delegation led by the Members of the Gujarat Assembly and the members of the Telephone Advisory Committee represented to the Government regarding the nonavailability of telephone connections in Baroda city for the past several years ;

(c) if so whether the Government have considered these demands ; and

(d) if so, whether Government have made any provision in the Fourth Five Year Plan to this effect ?

(c) and (d) Yes, Madam. The Government have made a provision for installation of a 1 KW medium wave transmitter at Baroda for Vividh Bharati Service and for construction of a permanent
