

**WRITING OFF OF ARREARS ADVANCED TO  
DISPLACED PERSONS FROM WEST PAKISTAN**

1731. SHRI JAIRAMDAS DAULATRAM : Will the Minister of LABOUR AND REHABILITATION be pleased to state :—

(a) whether Government have issued instructions to State Governments regarding writing off of arrears and interest due on small urban loans, advanced to displaced persons from West Pakistan; and

(b) whether copies of these instructions issued from time to time will be laid on the Table of the House including the Ministry of Finance letter No. D.236-F. 17(1) Reh. 1/53 dated 12th January, 1954 and No. i5(II)-B/57, dated the 24th February, 1958, as clarified in their letter No. F. i5(i)-B/58 dated the 15th September, 1969?
