## **REHABILITATION OF PERSONS UPROOTED DURING THE INDO-PAK CONFLICT**

1741. SHRI SYED HUSSAIN : Will the Minister of LABOUR AND RE HABILITATION be pleased to state :

(a) whether the persons who were uprooted from the border areas in Jammu and Kashmir and Punjab during the last Indo-Pak conflict have by now been completely rehabilitated; and

(b) if so, what is the total number of such persons ?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR, EMPLOYMENT AND REHABILITATION (SHRI BHAGWAT JHA AZAD) :

(a) and (b) As a consequence of the Indo-Pak conflict of August-September, 1965, nearly 52,000 persons in Punjab and 3 lakhs persons in Jammu and Kashmir were uprooted. Of these, no family remains to be rehabilitated in Punjab, while in Jammu and Kashmir the rehabilitation of 394 families who remain to be fully rehabilitated, is expected to be completed by 31-10-1969.

## **REHABILITATION OF REFUGEES IN STATES**

1742. SHRI JAGAT NARAIN : Will the Minister of LABOUR AND RE-HABILITATION be pleased to state :

(a) the total number of displaced persons who have come to India from countries other than West Pakistan so far and the number of displaced persons rehabilitated in each State;

(b) whether the proportion of displaced persons in Kashmir State (excluding Jammu) is lesser than those of other States; and

(c) if so, the reasons therefor ?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR, EMPLOYMENT AND REHABILITATION (SHRI BHAGWAT JHA AZAD) : (a) Indian nationals, who have been repatriated from other countries, and Tibetan refugees are not categorised as displaced persons. As such, information is furnished in respect of displaced persons from East Pakistan as under :

Displaced persons from East Pakistan.— About 50-27 lakh persons have migrated from East Pakistan so far.

Of the 41-17 lakh persons who migrated up to 31-3-1958, rehabilitation assistance has been given to about 6-68 lakh families. In their case, apart from some items of residuary work in respect of these settled in West Bengal, which are being reviewed by the Committee of Review, the rehabilitation work in other States has, by and large, been completed.

Migrants, numbering o-6i lakh, who came to India from 1-4-1958 to 31-12-63, were not eligible for relief and rehabilitation benefits.
