UNIVERSITIES WHICH RECOGNISE SINDHI

540. SHRI JAIRAMDAS DAULAT RAM: Will the Minister of EDUCATION AND YOUTH SERVICES be pleased to state :

(a) the names of the Universities which have recognised Sindhi language as a subject for (i) pass and (ii) honours course for the first, second and last year of the (1) B.A., (2) B.Sc. and (3) M.A. examinations;

(b) the names of the Universities which have provided staff for teaching the subject in each of the above courses and classes; and

(c) the number of students of each University who (i) appeared and (ii) passed with Sindhi as a subject at the (i) B.A. (ii) B.Sc. and (iii) M.A. examinations in each of the last three years ?

THE MINISTER OF EDUCATION AND YOUTH SERVICES (PROF. V. K. R. V. RAO) : (a) The University Grants Commission has informed that the Universities of Bombay, Calcutta, Delhi, Gujarat, Punjab and Punjabi have provision for allowing Sindhi as a subject of study at the Undergraduate level in the Faculty of Arts only.
