#### RACIAL RIOTS

664. PROF. SHANTILAL KOTHARI : Will the Minister of EXTERNAL AFFAIRS be pleased to state :

(a) the names of the countries where racialism is practised ; and

(b) what is the reaction of the Government of India to racial riots in those countries where persons of Indian-origin are affected ?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH) : (a) Racial discrimination in one form or the other is practised in a number of countries prominent among which are South Africa and Rhodesia.

(b) The Government of India consider such riots deplorable. Wherever such riots affect Indian nationals, appropriate measures are taken immediately. As regards persons of Indian-origin who are not Indian nationals, Government of India feel that they are the responsibility of the country whose nationality has been adopted by them.

#### PUBLICATION BY I. F. S. OFFICER

665. DR. (MILS.) MANGLADEVI TALWAR : Will the Minister of EXTERNAL AFFAIRS be pleased to state :

(a) whether the Government has seen a publication purporting to be from a book written by an Officer of the Indian Foreign Service about Soviet black-mail of an Indian official ; and

(b) if so, what are the contents of the book published ?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH) : (a) Some articles have been appearing in a serial form in a weekly magazine purporting to be from a book written by an officer of the Indian Foreign Service.

(b) The contents of the book, which we have no reason to believe has been written by any officer of the Indian Foreign Service, would appear to be directed against the good relations existing between India and the U.S.S.R.

#### SOVIET BASE IN ANDAMANS

666. SHRI THILLAI VILLALAN : SARDAR RAM SINGH :

Will the Minister of EXTERNAL AFFAIRS be pleased to state :

(a) whether it is a fact that Soviet Union have asked the Government of India for use of Andaman Islands as a Naval base; and

(b) if so, what is the reaction of the Government of India thereto ?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH) : (a) No, Sir.

(b) Does not arise.

#### TRADE TALKS WITH INDONESIA

667. SHRI B. K. MAHANTI : Will the Minister of FOREIGN TRADE AND SUPPLY be pleased to state :

(a) whether it is a fact that bilateral trade talks are proposed to be held with Indonesia to formulate proposals for securing better prices for pepper in the world market; and

(b) if so, what are the main issues that are proposed to be taken up and by what time a meeting is likely to be held ?

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE AND SUPPLY (CHOWDHARY RAM SEWAK) : (a) and (b) The question of evolving some arrangement to safeguard the unit price of pepper was *inter alia* discussed between officials of the two

countries. The talks were exploratory in nature, and are likely to be continued further.

#### P. M.'s TOUR OF JAKARTA

668. SHRI N. R. MUNISWAMY  
Will the Minister of EXTERNAL  
AFFAIRS be pleased to state :

(a) whether in her recent tour of Jakarta she suggested a broadbased grouping of nations to replace the existing ASEAN (Association of South East Asian Nations) and if so, what other nations are suggested to be included; and

(b) whether the Western countries will be admitted as associate nations ?

THE DEPUTY MINISTER IN THE  
MINISTRY OF EXTERNAL AFFAIRS  
(SHRI SURENDRA PAL SINGH) : (a) and (b)  
The Prime Minister suggested that regional economic cooperation in South East Asia had a greater potential of expansion through a broadbased grouping of nations with active United Nations participation. No specific views were put forward in regard to the membership or associate membership of such a group.

#### OPENING OF FIRE BY CHINESE TROOPS ON INDIAN SOLDIERS INSIDE INDIAN TERRITORY

669. SHRI N. R. MUNISWAMY:  
Will the Minister of DEFENCE be  
pleased to state :

(a) whether it is a fact that the Chinese troops recently opened fire on Indian soldiers in the Lipulekh area well inside the Indian territory ; and

(b) whether it is also a fact that of late there has been concentration of Chinese troops lately, in the middle sector and their activities all along the Indian and Nepali borders have increased ?

THE MINISTER OF DEFENCE (SARDAR  
SWARAN SINGH) : (a) and (b) On 10th July,  
1969, when an Indian patrol was proceeding  
towards Lipulekh Pass on the U.P.-Tibet  
border, the Chinese fired at our patrol from a  
direction east of the Pass, from their side of  
the international border. The Chinese fire was  
in effective and was not returned. There were  
no casualties. There was no

significant Chinese activity thereafter in the area.

While Chinese troops continue to remain in strength across our northern border, there is no indication that these troops have been recently augmented. A close watch continues to be kept in the interests of safeguarding our territorial integrity.

known to have been received from Cuba by  
some of Indian manufacturers and exporters of  
steel fabrications. Owing to tight supply  
situation and their prior commitments, it has  
not been possible for those who have received  
these enquiries to respond to them  
positively.
