THE DEPUTY CHAIRMAN : If you want to say anything, Mr. Shukla, you may do so.

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA) : Madam, this is a matter which is an internal subject of the Delhi Corporation and we cannot really interfere in this matter.

THE DEPUTY CHAIRMAN : She has brought in the question of the electoral rolls.

SHRI VIDYACHARAN SHUKLA : We shall take it up with the Election Commission who are responsible for this election and also the usual elections to the Delhi Municipal Corporation, and we shall request them to see that the rules and procedures, which have been laid down, are properly followed and there is no violation of the rules and procedures and no unhealthy practice is allowed to take place. We shall do it before this election takes place.
