## TRADE AGREEMENT WITH JAPAN

- .516. DR. (MRS.) MANGLADEVI TALWAR: Will the Minister of FOREIGN TRADE AND SUPPLY be pleased to state:
- (a) whether it is a fact that an agreement has recently been concluded between India and Japan regarding the import of Indian goods by Japan;
- (b) if so, whether it is also a fact that majority of the goods covered under the agreement are being produced in the private sector; and
  - (c) the other details of this agreement?

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE AND SUPPLY (CHOW-DHARY RAM SEWAK): (a) No, Madam. No agreement has been concluded between the Government of India and the Government of Japan for import by Japan of the Indian goods. However, a general Trade Agreement was concluded bel India and Japan on February 4, 19.r)S, under which the two countries had agreed to extend to each other the most-favoured-nation treatment in the matter of custom duties, regulations concerning imports and exports, shipping facilities etc. The two countries also agreed to cooperate with each other with a view to expanding trade and strengthening the economic relations. Copies of the Trade Agreement are available in the Parliament Library.

## VISIT OF INDIAN DELEGATION TO JAPAN

- 517. DR. (MRS.) MANGLADEVI TALWAR: Will the Minister of EXTERNAL AFFAIRS be pleased to state:
- (a) whether an Indian delegation led by Shri T. N. Kaul recently visited Japan; and
  - (b) if so, the outcome of the visit?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH): (a) Yes, Madam; from the 3rd to the 5th February, 1969.

(b) The consultative meetings between the officials of the Foreign Offices of India and Japan are held annually for exchange of views and for understanding each other's point of view. Various questions relating to bilateral relations between India and Japan, issues at the United Nations and international questions of interest to both countries, including the situation in South-East Asia, were discussed.
