

AZAD): (a) and (b) Some Associations/Organisations of displaced persons/repatriates approach the Department of Rehabilitation from time to time, generally making proposals in respect of some specific items of rehabilitation assistance for the migrants/repatriates concerned. Necessary action is taken on their representations in consultation with the State Governments concerned. In the absence of any specific reference to any particular Association/Organisation, time and labour involved in compiling information in respect of representations that may have been received by the Department from such Associations during any particular period are not likely to be commensurate with the result likely to be achieved.

(c) Information in regard to the details of the policy of the Government in the matter of relief/rehabilitation assistance to migrants and repatriates etc., and the progress of various rehabilitation measures, is contained in the Annual Report of the Department of Rehabilitation for the year 1968-69.
