

रेल मंत्री (डा० राम सुभग सिंह) .

(क) आवास के लिए तृतीय श्रेणी के कर्मचारी अपने वेतन के अनुसार टाइप II या III या IV के क्वार्टर पाने के पात्र है। साज-सामान के अनुमोदित मान के अनुसार टाइप II के क्वार्टरों में एक पखा, टाइप III में दो पखे और टाइप IV में तीन पखे लगाये जाते हैं। हालांकि दिल्ली और नयी दिल्ली क्षेत्र में तृतीय श्रेणी के कर्मचारियों के पास अधिकांश क्वार्टरों में अनुमोदित मान में पखे लगे हुए हैं, फिर भी दो कमरों के 109 क्वार्टर ऐसे हैं जिन्हें रेलवे ने केन्द्रीय लोक निर्माण विभाग से लेकर टाइप III का दर्जा दे दिया है। इन क्वार्टरों में एक पखा लगाया गया है जबकि अनुमोदित मान दो पखों का है।

(ख) यदि कर्मचारी कल्याण निधि में रकम उपलब्ध होगी, तो इन 109 क्वार्टरों में दूसरा पखा लगाया जायेगा।

†[THE MINISTER OF RAILWAYS (DR. RAM SUBHAG SINGH): (a) Class III employees are eligible for accommodation in Type II or III or IV quarters, according to their pay. As per approved scale of fittings, type II quarters are provided with one fan, type III with two fans and type IV with three fans each. Though most of the quarters occupied by class III staff in Delhi and New Delhi area have the approved scale of fans, there are however 109 two roomed quarters which the Railway had taken over from CPWD and which have been equated to type III quarters. These are provided with only one fan as against the approved scale of two fans.

(b) The second fan in these 109 quarters will be provided depending upon the availability of funds under Staff Welfare.]

ANCILLARY UNITS FOR FIAT PARTS IN U.A.R.

THE MINISTER OF INDUSTRIAL DEVELOPMENT, INTERNAL TRADE AND COMPANY AFFAIRS (SHRI FAKHRUDDIN ALI AHMAD): (a) and (b) The United Arab Republic Government has sought India's assistance for setting up one Ancillary Industrial Estate at Helwan near Cairo for the manufacture of Motor parts and components for automobiles and bicycles; and another General Industrial Estate at Mansoura. The services of a few experts have also been requested for the purpose. The request is under consideration.
