

(b) if so, the details of such referred cases alongwith the steps taken by the Central Government in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS (SHRI SURESH PACHOURI):

(a) Yes, Sir. The Government of Uttaranchal *vide* its letter dated 1/2.04.2004 has referred to Central Government the issue of allocation of employees of the Secretariat Cadre.

(b) The Government of Uttaranchal had requested not to allocate any more personnel of the Secretariat cadre apart from the 175 personnel already allocated on 'option' basis to that State, and to allocate 'vacancies' against the remaining posts. The Central Government, after considering the request of the Government of Uttaranchal, has already written to the State Advisory Committee *vide* its letter dated 26.8.2004 to consider the issue in accordance with the instructions of the Government of India.

Bypasses on National Highway in Kerala

*339. SHRI ABDUL WAHAB PEEVEE: Will the Minister of SHIPPING, ROAD TRANSPORT AND HIGHWAYS be pleased to state:

(a) whether any request has been received from the Government of Kerala for early construction of bypasses on National Highways in Kerala;

(b) if so, the details thereof;

(c) the status report of work started in each case; and

(d) by when the entire construction work is likely to be completed?

THE MINISTER OF SHIPPING, ROAD TRANSPORT AND HIGHWAYS (SHRI T.R. BALLU): (a) to (c) Yes, Sir. Government of Kerala on 20-7-2004 has submitted a proposal for early construction of 11 bypasses on National Highways in Kerala. The details are as under:
