Volume I consists of two notes on the state of education in India compiled by A. M. Monteath in 1802 and 1867, and part II on Education in British India prior to 1854, and in 1870-71 by A. P. Howell.

Volume II deals with development in University Education (1860-87), being the period covering the events leading to the establishment of the Universities of Punjab (now in Pakistan) and Allahabad, and including Hie papers relating to passing of Honorary Degrees Act 1 of 1884.

Selections from Educational Records. Pt. II (1840-59) edited by J. A. Ridley, is a reprinl and deals with the period during which provincial systems of education were evolved.

Volume IV is mainly based on MacDonnell's note (1886) and Buck's Report (1901) on technical education in India. If he wants more details I can give it but it is a long tiling.

- (ix) Central Direct Taxes administration.
- (x) Administration of Union Territories and NEFA;
- (xi) Personnel administration.
- (b) Government proposes to implement [he recommendations made in these reports Lo the maximum extent feasible.

SHRI K. CHANDRASEKHARAN: Is it proposed to have the Administrative Reforms Commission as a permanent Commission working continuously, or is it the 2809

intention that the Commission should exhaust its answers with regard to the terms of reference given to it? If it is the latter, when is the final report of the Administrative Reforms Commission expected to be available to Government? May I also ask, Madam, whether in a recent report submitted to the the Commission Go\ernment. recommended that instead of the second Saturday being a holiday in a month, all Saturdays should be half-holidays? May 1 ask whether the Government would be prepared to consider and reject this recommendation outright in the interest of work being carried on in Government offices, because if it is a half-holiday, there will be absolutely no work and all Saturdays will be full holidays in effect?

SHRI VIDYA CHARAN SHUKLA: Madam, it is well known that this Commission has been appointed to look into a specific problem, i.e., administrative improvements. They have almost completed their work. Most of the working groups, expert groups and study teams that they had appointed have submitted their reports and they have been processed, and as I indicated earlier, the Commission has submitted 11 reports to the Government. Now they are nearing the end of their work. They will take a little more time to round off the remaining part of their work. We have already reduced their staff because of the reduction in the quantum of work. We now expect that the work will be over soon. It will be very difficult to indicate how soon it will be over because we have not got any such indication from the Commission so far. But we ourselves are anxious that this work should be completed soon so that we can examine their reports

in a proper and quick manner and effect the improvements that are necessary.

About the last part of the lion. Member's question, I am not aware whether such a recommendation has been made or not. But if the Commission has made a recommendation of that kind, we shall certainly examine it.
