EXCLUSIVE IMPORTS BY S.T.C. AND M.M.T.C.

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE AND SUPPLY (CHOW-DHARY RAM SEWAK): (a) In the Import Policy for 1968-69 the import of ten kerns was exclusively canalised through the State Trading Corporation. No item was exclusively canalised through the Minerals and Metals Trading Corporation. Being a bulk importer. State Trading Corporation was able to obtair competitive prices thus facilitating supplies in the country at reasonable prices.

(b) In the Import Policy for 1969-70, six items have been added to the list of commodities the import of which is canalised through the State Trading Corporation. Also, the import of Mercury is now canalised through the Minerals and Metals Trading Corporation.
