

MINISTRY OF DEFENCE (SHRI I N MISHRA) (a) Yes, Madam

(b) A plant is being set up at Ranchi by the Garden Reach Workshops, to manufacture Marine Diesel Engines ranging from 390—27600 HP in collaboration with Messrs M A N of West Germany. Government's approval to the establishment of the project was accorded on 31-3-1967. At full production the rated capacity of the plant for various types of engines is 6 (Numbers) of high-powered engines, 60 (Nos) medium engines and 100 low-powered engines. The project is at present in the construction phase.

(c) The estimated capital cost of the project is Rs 363 lakhs.

(d) The work of site clearance was started in April, 1967. Construction of the main factory building was started in September, 1967 and is expected to be completed by June 1969.

(a) whether there is any scheme under consideration of the Government of India for promotion of the handicrafts industry in Madhya Pradesh during the current year,

(b) if so what are the details thereof and

(c) whether any scheme for promotion of handicrafts industry in Madhya Pradesh during the Fourth Five Year Plan period has been submitted by the Government of Madhya Pradesh and if so, the details thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE AND SUPPLY (CHOWDHARY RAM SEWAK) (a) to (c) The Government of Madhya Pradesh

have submitted a scheme for this year as well as for the Fourth Five Year Plan period. This scheme comprises

- (i) training of craftsmen and technical staff,
- (ii) quality marking of handicrafts,
- (iii) holding of competitions, seminars and exhibitions and of a Hand crafts week, and
- (iv) expansion of Central Handicrafts Design Centre including museum and library at Bhopal.

During the Fourth Five Year Plan an amount of Rs 15 lakhs has been proposed for allocation to the Government of Madhya Pradesh for the development of Handicrafts industry. Out of this sum, an amount of Rs 6 lakhs has been earmarked for 1969-70.
