- (a) All the three types of fertilisers, viz., Nitrogenous, Phosphatic and Potassic, are being imported from abroad.
- (b) Only nitrogenous and phosphatic fertilisers are produced in the country to a limited extent. Potassic fertilisers are not produced indigenously. Imports of fertilisers are arranged only to meet the gap between the indigenous production and the demand.
