

**P & T ADVISORY COMMITTEE IN MANI PUR,
TRIPURA, NEFA AND NAGALAND REGIONS**

891. SHRI JAGAT NARAIN: Will the Minister of INFORMATION AND BROADCASTING AND COMMUNICATIONS be pleased to state:

(a) whether there is any P & T Advisory Committee for Manipur, Tripura, NEFA and Nagaland regions;

(b) if so, when the said Committee was constituted and who are its members;

(c) whether there is any move for reconstituting the Committee; and

(d) if so, when?

THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING AND IN THE DEPARTMENT OF COMMUNICATIONS (PROF. SHER SINGH): (a) Yes Madam.

(b) The Advisory Committee for Manipur, Tripura, NEFA and N.H. T.A. was formed in March, 1961. Subsequently it was changed as for Manipur, Tripura, NEFA and Nagaland. The names of the present members of the Committee are given in the attached statement.

(c) No, Madam. Action is, however, taken to replace members as and when they complete their tenure of two years.

(d) The term of some of the members is due to expire in September, 1969.
