## STUDY OF ELECTION OFFENCES

16. SHRI CHITTA BASU: Will the Minister of LAW AND SOCIAL WELFARE be pleased to state:

(a) whether any study has so far been made about the election offences committed during the last General Election and mid-term election in different States:

(b) if so, the broad findings and conclusions of the study;

(c) whether Government propose to act upon those findings; and

(d) if so, the nature of the action contemplated?

THE DEPUTY MINISTER IN THE MINISTRY OF LAW AND IN THE DEPARTMENT OF SOCIAL WELFARE (SHRI MOHAMMAD YUNUS SALEEM): (a) and (b) Yes, Sir. A comprehensive study has already been undertaken by the Election Commission not only in respect of

election offences, but also for the amendment of election law in the light of the experience gained in the last general elections of 1967 and the mid-term general elections in February, 1969. The Commission proposes to place their concrete proposals before a meeting of the representatives of various parties in Parliament and final recommendations will thereafter be sent to the Government.

(c) and (d). The Government will give due consideration to the proposals of the Election Commission when they are received and take suitable action at the appropriate time.
