DESAI): (a) and (b) In the light of the guidelines set by the National Credit Council regarding commercial banks' lending to agriculture and small-scale industries, the Reserve Bank held individual discussions with 20 major banks. The targets indicated by these banks were that credit to agriculture and smallscale industries would rise by Rs. 44 crores and Rs. 74 crores respectively during July-June 1968-69. Since June, 1968 these banks have increased their advances to agriculture by Rs. 33.17 crores and small-scale industries by Rs. 41.31 crores. Progress in this regard is being watched by the Reserve Bank. It is hoped that by the end of June, 1969 the banks might realise the targets. COAL-BASED FERTILIZER PLANTS
